Daily Market Report

- Gold prices remain flat, trading between \$3,360 and \$3,400 amid consolidation and cautious sentiment.
- Markets weigh the Fed's data-dependent stance against rising geopolitical tensions, limiting price movement.
- The US Dollar pauses as President Trump consults his security team on the Israel-Iran conflict.
- > Juneteenth holiday in the US results in thin trading volumes, contributing to subdued gold price action.
- Middle East tensions escalate, with Israel vowing intensified attacks and directly threatening Iran's leadership.
- Russia warns against US involvement in Iran, calling it a move with "unpredictable negative consequences."
- Gold's support and resistance levels continue to hold, reflecting market indecision amid geopolitical uncertainty.


