Daily Market Report

- Gold climbs to a **one-week high** after attracting dip-buyers near **\$4,473–4,474**.
- Rising **geopolitical tensions** boost demand for safe-haven assets.
- **US military strikes in Venezuela** heighten regional instability concerns.
- **Saudi Arabia–UAE tensions** add to global risk sentiment.
- Ongoing **Iran unrest** and the **Russia–Ukraine war** support bullion prices.
- **Dovish Federal Reserve expectations** continue to favor gold bulls.
- Markets still expect **two US rate cuts** later this year.
- **Mixed US PMI data** reinforces bets on monetary easing.
- The **US Dollar retreats** from a multi-week high, aiding gold's rise.
- Concerns over **Fed independence under President Trump** pressure the USD.
- Investors await **key US data releases** for further Fed policy clues.
- Focus remains on **Friday's US Nonfarm Payrolls (NFP) report** for near-term direction.




